Terrorism Action Parameters

Several acts of terrorism that occurred in various

Therefore, we need to look at the parameters of

According to the 2019 Global Terrorism Index released by the Institute for Economics and Peace (IEP), it shows that the mortality rate caused by terrorist attacks has declined globally. However, the number of countries that still experience terror is dominantly increasing.

While reported by Media Indonesia (03/05/19), the

Global Terrorism Index in 2018, Mesuring the Impact of Terrorism, in the 2013-2017 period, there were 127 attacks by individuals / groups whose ideology of white supremacy / ultrakanans that took its toll 66 souls. From the data, it is indicated that ultrasound terror shows an increasing trend, both in the number of attacks and casualties.

Although there is a decrease in the number of deaths due to terrorist attacks, this certainly does not make all the roles of the state stop eradicating the understanding of radicalism which often gives birth to terrorism. Therefore, it is very dangerous for the sovereignty of the country and threatens the integrity of the people in this nation.

Role Solidity

Because the crime of terrorism is not a new term

that occurs and once in action can kill hundreds of people. We need to be aware of this violence, especially by the community and law enforcement officials, as well as interfaith leaders to look for potential loopholes in violent actions that arise from radical groups.

Its preventive role, the State Intelligence Agency

has a great responsibility to safeguard the sovereignty of the state from terrorism attacks so that it does not easily trigger the destruction and damage to the joints of the life of the nation and state. Because terrorism is our common enemy that must be fought and fought with with our consciousness.

In addition, the educational role is from the

National Counterterrorism Agency which has a de-radicalization program to continue actively building former terrorist inmates to be able to become a doorway for people before entering the terrorist group. And strengthened by national and religious insights as a solution to close the space for potential violence.

Acts of terrorism whose motives are religious

doctrine and state economic policy must be made important lessons by the state. In this case, the government should conduct a review and arrange the institutions that are authorized to eradicate terrorism, and improve future strategies so that they can run more effectively.[Khalilullah]
